Approve a request from the Delano Area Chamber of Commerce for Outdoor sales – Sidewalk sale – Annual City Wide Garage Sale on August 12-14, Temp On-sale Intoxicating Liquor (Wine Tasting) for the Taste of Delano Event on August 4, 2010, and a Public Facilities Lease Agreement for Use of the Central Park for the Taste of Delano.

ACTION REQUESTED

Approve a request from the Delano Area Chamber of Commerce for Outdoor sales – Sidewalk sale – Annual City Wide Garage Sale on August 12-14, Temp On-sale Intoxicating Liquor (Wine Tasting) for the Taste of Delano Event on August 4, 2010, and a Public Facilities Lease Agreement for Use of the Central Park for the Taste of Delano.

BACKGROUND

The Chamber is hosting several events this summer. The Annual City Wide Garage Sale (aka as Crazy Day) is slated for August 12-14. The local business community display their wares along the sidewalks of the business. Residents are welcome to sign up for a Chamber sponsored City wide Garage sale. The residents for a fee can have their respective garage sale listed on a Chamber' flyer/map. The Council will need to approve a permit for temporary outdoor sales and authorize the use of public sidewalks for the sales.

The Taste of Delano is scheduled for August 4, 2010 at the City's Central Park. The Chamber will be hosting a wine tasting event as part of this promotion. The City Council will need to approve a license for the temporary on-sale liquor license, a permit for temporary outdoor sales, and a lease for the use of the City Central Park.

The City has received a general liability certificate of insurance that covers all the aforementioned events. Staff has informed the Chamber's agent of record that a Liquor Liability policy or special events policy will need to be issued for the wine tasting event. The City of Delano will be named as additional insured. The Chamber is also requesting a waiver of the fees.

Staff is recommending approval of the Chambers request for a Outdoor sales – Sidewalk sale – Annual City Wide Garage Sale on August 12-14, Temp On-sale Intoxicating Liquor (Wine Tasting) for the Taste of Delano Event on August 4, 20010, and a Public Facilities Lease Agreement for Use of the Central Park for the Taste of Delano subject to receipt of the Liquor Liability – Special Event coverage which names the City as additional insured and to waive any permit or lease fees.
