### **Delano Splashpad Terms and Conditions:**

#### **Season Pass Rules and Regulations:**

- Visitors must present their Season Pass card or key tag for entrance to the Splashpad.
- The Season Pass will be accepted for unlimited admission into the Delano Splashpad during the 2018 season for the individuals listed on the application.
- Season Passes may not be transferred or shared with another person not listed on the application.
- If your card is lost or stolen, please alert City Hall (763-972-0550) and we will deactivate the card. Replacement cards will cost \$2.00.
- Season Passes will be deactivated at the end of the 2018 season. You may renew your membership in spring 2019.

## **General Splashpad Rules:**

- No food or drink is allowed on the splash deck.
- Personal toys and chairs are not allowed in the Splashpad or Concession Building.
- Aquatic wheelchairs are available to use for persons with disabilities only.
- Children entering 5<sup>th</sup> grade and younger must be accompanied by a chaperone.
- In the event of an emergency and a parent/guardian is not readily available, staff will use the contact information listed on Page 1 of this document.

#### **Hours:**

- Every effort will be made to honor the posted Delano Splashpad hours, which are 12:00 pm to 8:00 pm from opening day until September 3, 2018.
- The Delano Splashpad will close if any of the following conditions occur:
  - o The temperature is below 70 degrees. Staff will use discretion.
  - o A Severe Thunderstorm and/or Tornado Watch or Warning is issued for the Delano area
- The Splashpad may reopen if conditions warrant following a weather-related closure.
- If the Splashpad is closed, the City will post closure information on its website and social media accounts.

#### Waiver of Liability:

- I agree to allow the individuals listed on Page 1 of this document to participate in all activities at the Delano Splashpad. I agree to abide by all posted rules and regulations.
- My use of and participation in activities the Delano Splashpad (hereinafter referred to as this "Activity") is voluntary and no one is forcing me to participate. I acknowledge that this Activity is <u>NOT</u> an <u>ESSENTIAL</u> service provided by the City of Delano (the "City").
- I understand and acknowledge that this Activity has certain risks, including but not limited to personal injury. I understand that these risks known or unknown, anticipated or unanticipated may result in injury, death, illness, disease, or damage to myself or my property, or to other persons and their property.
- In consideration of being allowed to use and participate in this Activity, I hereby personally assume all risks in connection with this Activity and I hereby agree to hold the City, its officials, employees, agents and contractors harmless and I waive any right to make claims or bring lawsuits against the City or anyone working on behalf of the City for any injuries or damages related to the alleged negligence of the City.
- This waiver does not apply to any injuries or damages that are the result of any willful, wanton, or
  intentional misconduct by the City or anyone acting on behalf of the City.
- I understand that entering into and signing this agreement affects my legal rights and results in my giving up or waiving certain legal rights, and I accept and sign this agreement of my own free will.
- The terms of this agreement shall bind the members of my family, if I am alive, and my heirs, assigns and personal representatives if I am deceased.

### Season Pass, Day Pass, and Private Event FAQ

#### Who has to be included on a waiver?

Any visitor who interacts with the water must have a Season Pass Application & Waiver on file with the City.

# Who has to pay for a Day Pass?

Any visitor who interacts with the water at the Splashpad must pay the Day Pass fee. Chaperones who are at the Splashpad to only oversee children do not need to pay for a Day Pass.

# If I have a Season Pass, can I get a discount during a Private Event rental (10:00 am to 12:00 pm only)?

The Private Event lessee will be charged one rate regardless of how many people in the group have a Season Pass. Visitors must discuss pricing with their Private Event contact person. No money will be taken or refunded from individual visitors during Private Events.

## If I am part of a Private Event, can I stay past 12:00 pm?

All visitors are welcome to stay as long as they like at the Delano Splashpad. However, once a Private Event concludes as 12:00, these visitors must relocate to non-rented areas. They must also pay a Day Pass fee or present their Season Pass if they would like to stay past 12:00.

### If I rent the Concession Building, does it include Splashpad admission?

For a block rental (up to 6 hours) or full day rental of the Concession Building, Splashpad admission is not included. At any time during the rental, visitors may use the Splashpad after first presenting a Season Pass or paying a Day Pass fee, with Splashpad Application & Waiver if needed.
