 - A. County Crosswalk Safety Improvements Update

Phil Kern briefly updated Council on the status of the crosswalk updates. Council directed Staff to quote county road 30 and did not receive any quotes back. Staff is looking into further options for the project and are recommending to 1. Quote at a later date or 2. Self-perform the bulk of the work through Public Works. Kern discussed the project with Public Works staff and they are willing to take on the project. Council discussed the project; consensus was to move forward with the project with Public Works staff.

B. Motion authorizing removal of a portion of fence near 3rd Street along Railroad Avenue

Phil Kern stated community groups in the 1980s installed sections of fencing along Railroad Avenue to prevent pedestrian traffic along the railroad. The fence is aging, and in several sections, has been removed and/or damaged through the process of construction along Railroad Avenue.

Staff is recommending removal east of 3rd Street, largely because no fencing exists further to the east. Additionally, fence on the south side of the Railroad along Franklin Avenue will restrict immediate pedestrian crossing. Staff is looking for Council direction, and authorization to proceed if the Council is agreeable.

Motion by Betsy Moran, seconded by Jason Franzen to authorize removal of a portion of fence near $3^{\rm rd}$ Street along Railroad Avenue; motion carried.
